Rex Granite hereby warrants to the original purchaser that the granite chosen for this memorial was chosen for the excellent quality of natural color*, grain*, and durability; and the workmanship provided is held to strict quality standards.

- ❖ This warranty is valid for the life of the original owner and the owner's heirs/assignees if the memorial was fabricated by Rex Granite Company.
- ❖ If granite utilized in this memorial is manufactured by our Import suppliers, Rex Granite Company will warranty the memorial for 2 years from the date of purchase.
- ❖ Any and all claims against this warranty must be submitted in writing with proof of purchase to Rex Granite Company. Verification of said claim must be achieved by our inspectors or an authorized agent of Rex Granite Company.
- ❖ This warranty covers the Granite only. Rex Granite will replace or repair any memorial deemed defective as attributable to the granite or workmanship. The cost of repair or replacement will be borne by Rex Granite Company or its authorized agents. If replacement is deemed necessary, replacement will be made with granite as similar as possible to the original stone in color*, grain* and quality. This warranty in no way authorizes the party seeking the claim to incur any expenses toward repair/replacement without prior written consent from Rex Granite Company.
- ❖ This warranty does not cover the following: Shipping and installation, vases of any material, porcelain photos, bronze medallions/markers/plates, or additional adornments of any kind, lettering, carvings, laser and hand etchings, lithochrome paint, cleaning of accumulated dirt/debris, or effects created by vandalism, theft, war, terrorism, flood, acts of God or nature, fading, staining or cracking from environmental causes, damage to the granite from defective foundations constructed by others or acts of omission by any party including the purchaser.
